  - 0 Physical Assault – injured
  - 0 Use of Weapon
- Other (*bitten by dog, clients with knife, loaded gun, gun, bullet*)

- Other (*dogs, client's neighbor, unknown, foster parents*)

**Location of Incident**

- 16 Client Home
  - 16 Agency
  - 2 Provider Agency
  - 1 Victim's Home
  - 11 Phone / Email
  - 2 Court
  - 5 Foster home
- Other (*school, jail*)

**Incident "Trigger"**

- 13 Visit as part of C/A,N investigation
  - 7 Removal of Children
  - 10 Routine Home Visit
  - 12 Custody Discussion, Pending Action
  - 7 Parent Visit with Child
  - 0 Court hearing
- Other (*financial discussion, disagreement w/foster parents, teen picked up on missing report*)

**Post Incident Responses**

- 1 Victim Received Medical Attention (*from dog bite*)
  - 14 Law Enforcement of local jurisdiction contacted for Agency and Victim
  - 54 Incident Reported to Agency
  - 1 Employee Assistance Program Offered / Provided
  - 0 Warning Letter Issued
  - 1 Incoming Phone Calls to Victim Taped
  - 4 Offender/s Picture Posted w/in Agency for Security Purposes
  - 7 Law Enforcement Intervention
  - 0 Charges Filed Against Alleged Offender
  - 0 Post Incident Training Scheduled/Conducted
- Other (*dog removed, case assigned, client flagged in the system, child removed from foster home, clients removed from property*)
