**WELCOME RHONDA REAGH**— Dr. Rhonda Reagh has officially joined the PCSAO team as Assistant Director. As the former Director of Greene CCS, Rhonda is extremely knowledgeable, experienced and well respected by everyone. Primary responsibilities will include co-chairing the Ohio Child Welfare Training Program Steering Committee; supporting and promoting organizational excellence items such as staffing the PCSAO Human Resources Committee, Council on Accreditation, and the University Partnership Program; providing technical assistance to members, as requested (including levy assistance!); supporting Alternative Response expansion, and staffing the Public Information Committee. Sound like a lot? Rhonda is excited about it, and we are thrilled to have her here. Hooray for PCSAO!

**SSI APPLICATIONS FOR EMANCIPATING FOSTER YOUTH**— Effective immediately, the Soc Security Admin may accept an SSI application from a disabled youth in foster care up to 90 days before federal foster care payments are expected to end. This is an exception to the general rule of accepting an SSI application in the month before the month of eligibility. This really helps our children in custody emancipating out of foster care. **SAMSHA WEB CAST ON CHILDREN'S MENTAL HEALTH**— On Wednesday January 27, 2010 SAMHSA presented a WEB Cast for State Mental Health Leadership to outline priority areas for this agency with respect to children's mental health in the Obama Administration and working with the states and local communities.

Pam Hyde, the newly appointed director of SAMSHA, and formally Director of the Ohio Department of Mental Health led the Web Cast. Immediate research shows that 1 in 5 children in the United States have a Mental Health Diagnosis and right now we continue to address this issue across a system of silos: Mental Health; Juvenile Justice (50%-60% mental health diagnosis); Child Welfare (50%-mental health diagnosis); Education; and Health Care (including Medicaid).

SAMSHA staff is working with their colleagues at Health and Human Services, US Department of Education and Justice to break down these silos so that they can plan programs and funding to address the needs of these children rather than the systems they are in.

SAMSHA's Priorities:

1. Prevention and Wellness, Many of the illnesses that children experience could be prevented with focus on family supports and engagement and community engagement. This will be a focus across all programming in HHS with programs such as Home Visitation, and programs to prevent violence and trauma.
2. Trauma Informed Care. With 1 in 4 or 26% of our country's children experiencing serious violence before they complete adolescence it is essential that we prevent, intervene and treat trauma with evidenced based practices.
3. Support for military families: Both soldiers returning and families waiting for returning members are facing huge stresses and experiencing rising cases of mental illness including Post Traumatic Stress Syndrome. Supports must be provided for these families at the community level.
4. Health Reform: Although no one at this time knows exactly what will be in the finally passed National Health Reform Package it is hoped that things such as EPSDT covering treatment for mental illness for children and Home Visitation, and expansion of Medicaid for youth until they are 25 will stay a part in the Bill so we can serve our children and families.

Across all the priorities of SAMSHA as well as the other programs is the focus on Evidenced Based and Evidenced Informed Care such as: Multi Systemic Treatment; Functional Family Therapy; Multi Systemic Treatment Foster Care and Wrap Around. Performance Measurement Systems such as collecting client level data on outcomes for case decision making and continuous quality improvement are also necessary.

**OCWTP'S TARGETED NEEDS ASSESSMENT**— The OCWTP is currently engaged in a targeted needs assessment process looking at a variety of data sources (CFSR and CPOE findings, etc.) to help identify priority training needs of county staff and foster caregivers. Thus far, 9 counties have provided feedback to the OCWTP though focus groups and another 7 are scheduled. Findings will provide direction to several OCWTP initiatives. **TANGIBLE PERSONAL PROPERTY TAX WORK GROUP MEETING**— The workgroup that the Governor had supported forming after passage of the 2010/2011 Biennial Budget to address the phase out of the Tangible Personal Property Tax met on Monday January 25, 2010. As we know in the budget bill \$11 million was included in the budget to cover the loss in 2011. However, the deficit grows considerably in the out years with all funding being phased out by 2018. The Ohio Tax Department gave a wonderful presentation about the history of this decision in HB 66 ( with respect to tax reform ) but also

showing the present and future anticipated performance of the CAT tax, which is the source that was to be used to provide the states share of funding for the replacement dollars through 2018. It was clear that there certainly would not be enough CAT dollars to replace all of the new dollars needed to make up the total loss that local governments will be losing.

This brings us to the goal of the work group: to come up with proposals to give to the Administration for the 2012/2013 Biennial Budget for a permanent solution for the loss to local governments of the TTPT. At our next meeting we will be discussing some of the proposals our Local Government Coalition have considered over the past two years as possible options.

**KINSHIP NAVIGATOR GRANT NEWS** – the HHS Kinship Navigator Grant in seven counties (Ashtabula, Clark, Crawford, Hardin, Lorain, Portage, Richland) is moving right along, here is an update:

- Local Kinship Navigators hired
- Training held 1.27.10 by Dr. Denise Goodman w/ collaboration with OCWTP – 21 Kin Navigators and Supervisors trained
- All Kin Navigators will be trained as Benefit Bank counselors
- Progress for connections with 211 and other local I & R processes
- Lots of PR / Outreach
- PCSAO is building separate Kinship website to be launched soon!
- Heavy focus on evaluation activities, data collection, counties will use a common web-based tool for data collection and assessment
- Each county has a Local Advisory Group (multi-system for education, collaboration, system change)
- Ohio Statewide Kinship Caregivers Advisory Council to serve as Statewide Advisory Group (SAG) – for education, collaboration, policy and practice enhancement and sharing, system change.

**HB 197 KINSHIP BILL**— this budget neutral bill would expand the HB 130 Grandparent Power of Attorney and Caregiver Authorization Affidavit forms out to other kinship caregivers. Now we have six years of experience and value using the forms, plus an evaluation from Wright State University that shows big value among grandparent caregivers; no safety issues; no implementation problems with courts, caseworkers, schools; and need with other kin caregivers.

A hearing in House Judiciary was held Wed, Jan. 27, 2010. A great line up of proponents came, that described how well the grandparent forms work, and ongoing barriers experienced by non-grandparent kin caregivers. Two awesome caregivers (grandparents and aunts) clearly described unnecessary bureaucracy and barriers they faced while trying to get kids in their care enrolled in school. Also, Patrick Donovan of Muskingum CCS that highlighted a young man that stayed out of school for most of the year waiting for judicial action (thankfully he did graduate and is on to better things); Dawn Yeakley of Clinton CDJFS that gave several examples of relative caregivers unable to get kids enrolled in school in a timely fashion due to documentation issues; Dionne Simmons of Dayton's Center for Healthy Communities that explained their active local use of HB 130 forms (hundreds last year) and the local task force that created a process for smooth sailing; and PCSAO's Crystal Allen to summarize history, data and issues. Courts however, continue to feel discomfort with expanding the policy, as when kinship (or any) families do come to their attention, there are usually significant problems – thank goodness we have the courts to turn to in those situations! Sponsor Marian Harris will coordinate a stakeholders meeting, including members of the judiciary, to further discuss.

**NAPCWA SPRING CONFERENCE**— The NAPCWA Spring Conference will open on Friday, March 26, with a *special pre-conference Town Hall Meeting on child welfare financing*. The APHSA meeting begins on Sunday, March 28, and continues through Tuesday, March 30; both are at the Fairmont Hotel in downtown Washington. **CENTER FOR EARLY CHILDHOOD DEVELOPMENT**— Created as part of Ohio's last biennial budget, you get an idea of the goals and vision, and take a look at the Implementation Plan at <http://www.build-ohio.org/> (link on right of home page). PCSAO recently participated in a stakeholder's focus group led by Alicia Leatherman, most gave kudos to the planning group for an ambitious plan. Our group did suggest that the planning group consider integrating Strengthening Families as a unifying framework for the plan. SF is not a program, but a frame to instill five Protective Factors with parents, early childhood caregivers and others that work with and support young families (like child welfare workers!) It builds on strengths of parents and families and community. The positive possibilities are exciting.

**ONE-THIRD OF TEEN MOTHERS DON'T EARN A HIGH SCHOOL DIPLOMA OR GED**— Here is yet another reason to invest in teen pregnancy prevention efforts. Child Trends research finds that one in three (34 percent) young women who had been teen mothers did not earn a high school diploma or a GED, compared with only 6 percent of young women who had not had a teen birth. "Earning a high school diploma or GED reduces the risk of subsequent teen pregnancy, which has been linked to even poorer outcomes," said Kate Perper, M.P.P., lead author of the study. "Higher parental education is also linked to improved outcomes among children that may reduce their risk of early sexual activity and teen pregnancy, thus reducing intergenerational cycles of disadvantage." Other discussion included CPOE, PCSA policy assistance, and an upcoming broad salary survey. Last but not least, Stacy Saunders led an IHS Needs Assessment IHS Focus Group concerning not only training needs but also the best methods and vehicles for specific trainings. Fruitful discussion was had specifically on the topics of service provision and permanency. Several group members made very positive remarks with regard to networking trainings that OCWTP has facilitated in the past. Date for next SE District will be identified for a day in February for a special meeting on CHIPS.
