

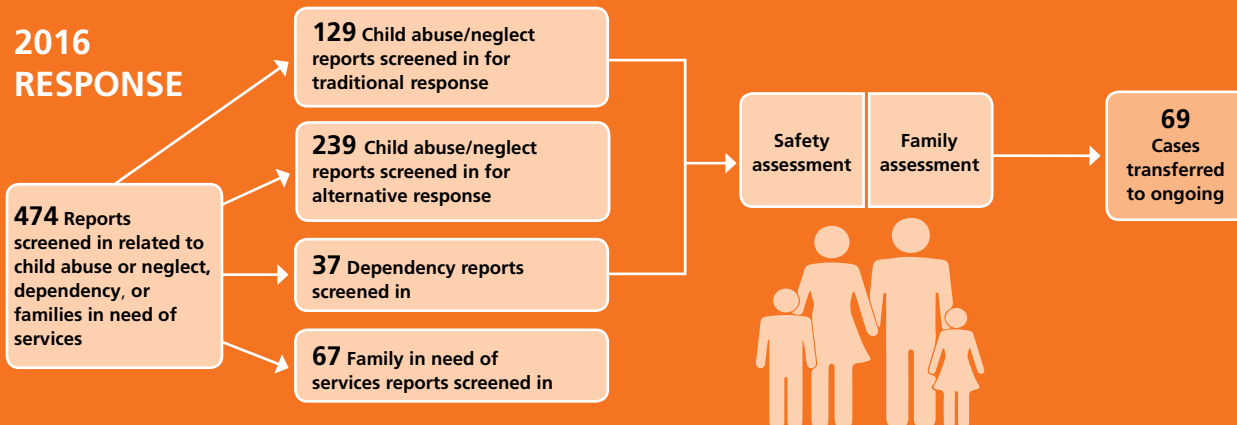

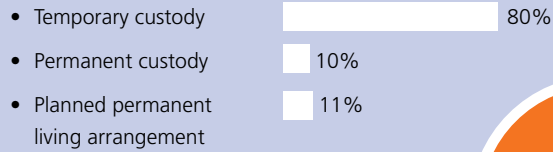

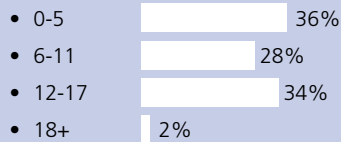

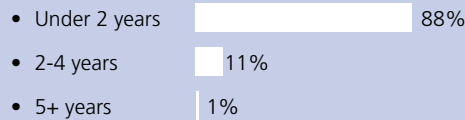

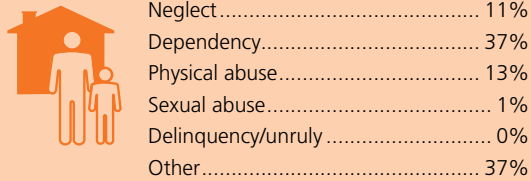

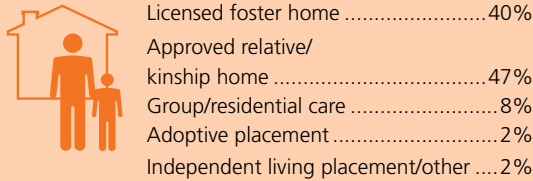

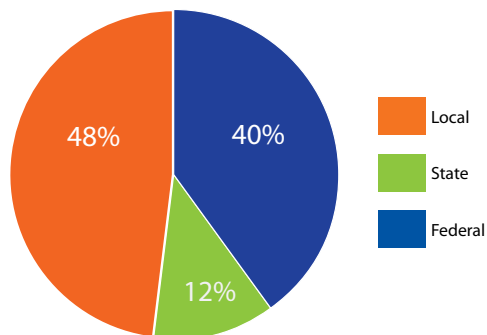
Costs by source
