#### Social Services Worker II- Child Protective Services

**MINIMUM QUALIFICATIONS:** Bachelor's degree in Social Work or related human services field. Previous protective service experience and/or master's degree preferred.

**CLASSIFICATION:** Social Services Worker II, Pay Range 8 - **\$19.21 to \$25.72 per hour based on protective services experience**

**DUTIES:** Primary duties include receiving, documenting, and screening allegations of child abuse/neglect. When needed, individual may provide a wide range of casework services to children and families. These duties may include any or combination of any of the following:

- Investigation and/or assessment of child abuse/neglect referrals;
- Maintenance of a caseload of families/children who require protective assistance;
- Provision of adoption and post adoption services to children and families.

Additional duties required based on functional job description include receiving and documenting allegations of child abuse/neglect and sharing with teammates in 24/7 on-call rotation (with associated on-call stipend).
