#### **DESCRIPTION:**

Summary of Essential Duties

The primary purpose of the Social Services Worker 2 position is to investigate claims of abuse and neglect of children.

In addition, the classification prepares child cases for court, meets procedural deadlines governing the management

of social services cases set by the State of Ohio and ensures that this documentation is complete, and could serve

as on-call social service worker (e.g., on weekends, holidays, after business hours).

#### **DUTIES:**

55% Conduct initial interviews with public for abuse/neglect investigations; collect, organize and receive abuse/neglect referrals from case-workers, other agencies

and the general public, and develop documentation for permanent case record.

Refer to higher level Social Service Worker and/or Supervisor for further case

determinations; advise public of agency procedures. Complete forms, reports, case records, logs and correspondence; input data into computerized logs (e.g.,

SACWIS); organize record documentation (e.g., photos, audio/video tapes, handwritten/typed notes, written summaries, risk assessment packets, case plans, Central Registry and Conclusion Forms) for supervisory approvals and agency record retention program. Provide information and referral services for clients not accepted for direct service; maintain contact with other agencies; provide clerical support (e.g., answering telephone, copying, typing, filing, sorting, mailing); assist supervisor in preparing reports and data collection.

30% Provide additional coverage as assigned by supervisor for casework related activities including but not limited to conducting home visits,

initiating/completing investigations, securing out of home placements which best meet client's needs in a least restrictive setting. Provide in home or foster care contacts, transport clients as necessary, attend case related meetings, etc.

10% Participates in CWIT curriculum as directed by immediate supervisor. Participate in ongoing training, supervisory/staff meetings, staff consultations and other related management support tasks.

5% Perform other duties as assigned.

#### **QUALIFICATIONS:**

Minimum Qualifications

Per Section 5153.112 of the Ohio Revised Code, applicants of a Public Children Services unit must have one of the

following:

- 1. A bachelor's degree in human services-related studies, or
- 2. A bachelor's degree in any field and have been employed for at least two years in a human services occupation, or
- 3. An associate's degree in human services-related studies, or
- 4. Been employed for at least five years in a human service-related occupation.

For employment to continue, a person described in Option 2, 3, or 4 above must obtain a jobrelated bachelor's degree

not later than five years after the date employment with the agency commences.

Per Section 5153.122 of the Ohio Revised Code, each caseworker shall complete at least ninety hours of in-service

training during the first year of the caseworker's continuous employment, consisting of courses in recognizing and

preventing child abuse and neglect, assessing risks, interviewing persons, investigating cases, intervening, providing

services to children and their families, and other topics relevant to child abuse and neglect. After the first year of

continuous employment, each caseworker annually shall complete thirty-six hours of training in areas relevant to the

caseworker's assigned duties. In addition, applicant must have valid driver's license.
